- Rookie W/T**- 1<sup>st</sup> year of showing OR 7 yrs old and younger
- Limit Rider Crossrail**- beginner riders in 1<sup>st</sup> or 2<sup>nd</sup> year of showing. Green horses must courtesy, will not be judged. Rider not eligible to show over 2'3". Any age rider. No oxers.
- Beginner Rider**- rider any age and never shown over 2'3; no oxers.
- Green as Grass**- Open to pros and non-pros. No oxers.
- Modified**- unrestricted, oxers allowed. Open to pros and non-pros.
- Pre-Child/Adult**- any age non-pro rider, rider never having shown over 2'9" in past 2 yrs. Oxers allowed.
- Open**- unrestricted, oxers allowed. Open to pros and non-pros. Horse cannot show in crossrails or 2'-2'3" at same show.
